- In requesting permission to reproduce materials from the collections of the Santa Monica History Museum as described, the requester agrees to hold harmless the Santa Monica History Museum and its Trustees, Officers, and agents either jointly or severally from any action involving infringements of the rights of any person or their heirs and descendants in common law or under statutory copyright.
- Permission to reproduce material in which reproduction rights are reserved must be granted by signed written permission of the persons holding those rights.
- Consideration of the requirements of copyrights is the responsibility of the author, producer, and publisher. Applicants assume all responsibility for questions of copyright and invasion of privacy that may arise in copying and using the materials.

Copyright Restrictions
